Public Education in Alabama

This publication is the combination of what were formerly the Alabama Education Report Card, a federally mandated publication, and the Alabama State Department of Education Annual Report. Because much of the information previously included in the Annual Report was similar or identical to what was required in the Alabama Education Report Card, the two were collapsed into one informative, yet efficient and practical publication. This publication meets the requirements of the *No Child Left Behind Act of 2001*, Public Law 107-110, and the Code of Alabama (1975), Section 16-3-21. In a more consistent and viable manner than ever before, education in Alabama is moving toward its ultimate goal of providing every student with a quality education, thereby preparing them for work, college, and life after high school. Alabama's graduation rates from 2002 to 2008 increased significantly, tripling the national average increase and ranking fourth in the country. Alabama's progress in Reading continues to prove the state's reading initiative is effective. Educational assessments clearly show the historic gains Alabama made in Reading in 2007 (greatest gains in Reading in America and in the history of the National Assessment of Educational Progress) continue to remain steady. Alabama's trailblazing distance learning program, ACCESS, remains a spectacle of achievement recognized and reported on by national television programs and newspapers across the country. The state's success with Advanced Placement (AP) classes, both in the number of students taking AP classes and the diversity of students taking AP classes, is phenomenal (the number of African American AP test takers has more than quadrupled since 2004). In addition, the Alabama Math, Science and Technology Initiative (AMSTI) has been recognized by the Center for Excellence in Education, a national think tank, as an "exemplary model of laboratory education" in the United States.

Still, all of these accomplishments barely scratch the surface of what all is being done to improve the quality of education in Alabama. However, even with the fevered pitch that the State Board of Education, school administrators, teachers, parents, and students are demonstrating improvement, much, much more remains to be done. Faced with unprecedented financial challenges and unforeseen obstacles, the business of education in Alabama keeps moving forward. Together, we can continue to strive toward the goal of a first-class education for every student – a goal that our state cannot afford to fail to meet.

No Child Left Behind State Report Card

The federal *No Child Left Behind Act of 2001* (NCLB) requires public accountability reports at the school, system, and state levels that include the status of adequate yearly progress (AYP), attendance and dropout/graduation rates, student assessment data disaggregated into subgroups, and information on "highly qualified" teachers.

To meet these requirements, the Alabama Department of Education incorporates the NCLB State Report Card in the Alabama's Education Report Card, which provides statewide information incorporating all NCLB conditions.

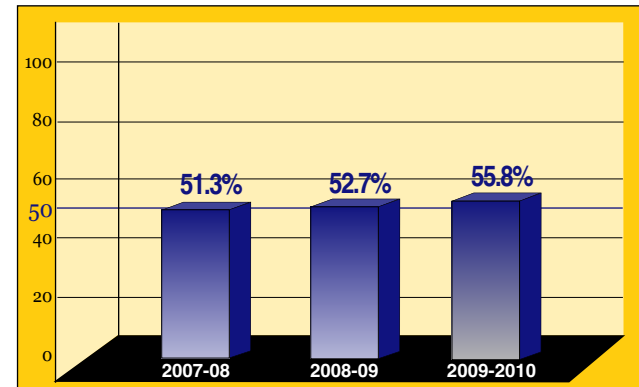

Schools in School Improvement

A school that does not meet 100% of its goals in order to make Adequate Yearly Progress (AYP). A school that does not make AYP for two consecutive years in the same component (reading, mathematics, or the additional academic indicator) will be identified for School Improvement Year 1. If the school does not make AYP the next year in the same component, it will move to School Improvement Year 2, etc.

Once in School Improvement, if a school makes one year of AYP in the same component,

it does not advance to the next level of improvement, but retains its current improvement status in the component – also known as the delay provision.

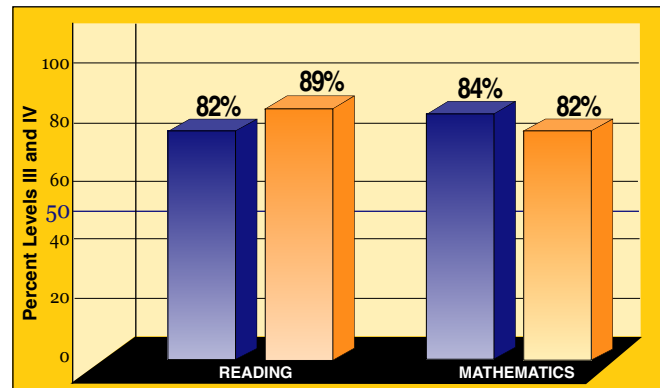

Students must pass the *Alabama High School Graduation Exam* (AHSGE) to earn a high school diploma. The chart shows the percent of 11th and 12th graders who passed each subject-area test of the exam. The percent passing reflects Levels III and IV (meeting or exceeding academic achievement standards). Annual Measurable Objectives (AMOs) are the annual requirements for the percentage of students in Grade 11 at Levels III and IV for AYP. 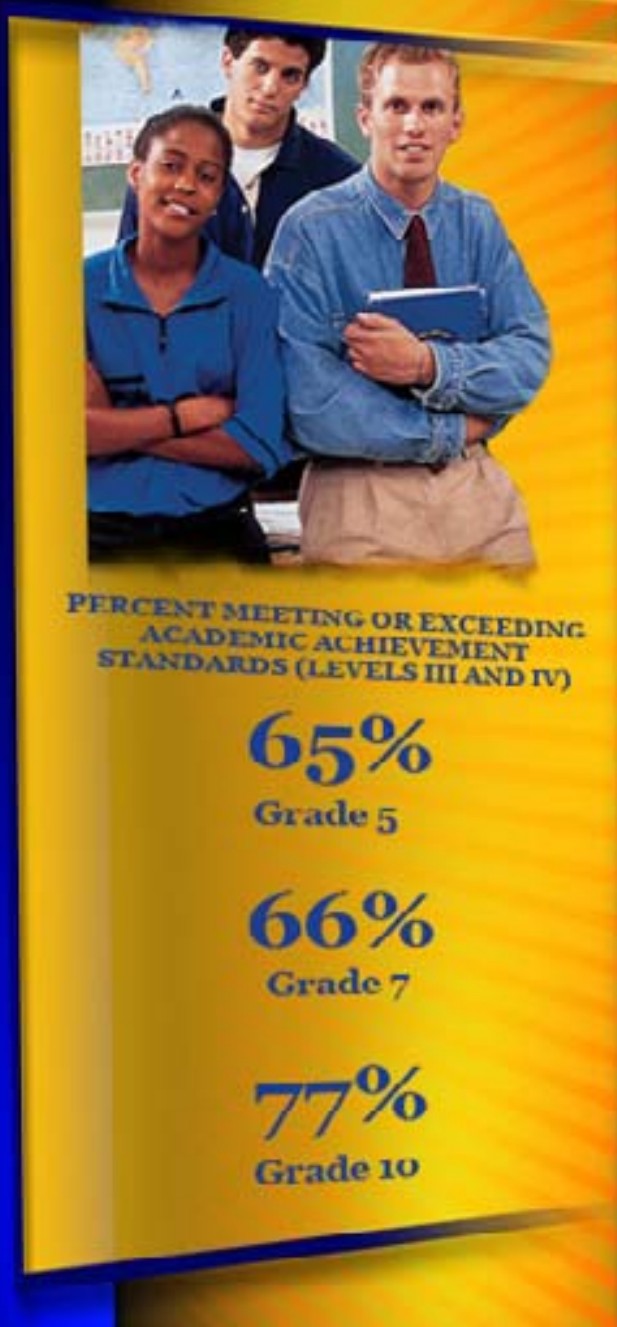

Alabama students participate in Alabama’s assessments every year at each subject and grade level, but only a small representative sample of Alabama students participate in NAEP reading and mathematics, which is administered every other year (not administered for 2010).

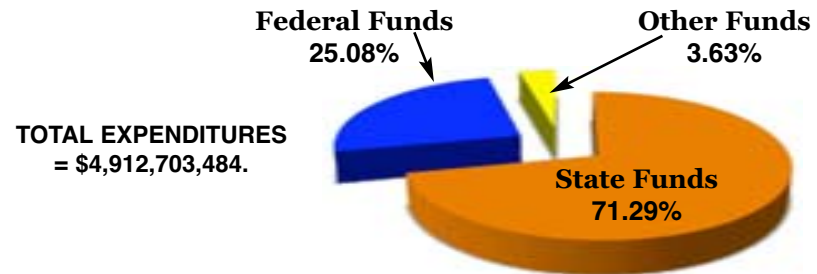
