

**MINUTES OF THE ALABAMA STATE BOARD OF EDUCATION
THE STATE OF ALABAMA
APRIL 14, 2016
MONTGOMERY, ALABAMA**

The Alabama State Board of Education met on Thursday, April 14, 2016, at 10:13 a.m., for a regular meeting of Elementary/Secondary Education matters. The meeting was called to order by the Vice President of the Board, in accordance with *Alabama Code* (1975), §16-3-7, as amended.

**APPROVAL OF THE MINUTES FOR THE MEETING OF MARCH 10, 2016, AND THE
SPECIAL-CALLED MEETING OF MARCH 14, 2016**

On motion by Mrs. Ella B. Bell and seconded by Mrs. Stephanie Bell, the Board voted unanimously to adopt the minutes for the meeting of March 10, 2016, and the Special-Called Meeting of March 14, 2016.

APPROVAL OF AGENDA

On motion by Mrs. Stephanie Bell and seconded by Dr. Yvette Richardson, the Board voted unanimously to approve the agenda.

Before the selection of the Interim State Superintendent of Education, the State Board discussed the salary. The Interim State Superintendent's salary will be prorated for the period of time served and reverted back to the previous salary the individual received before being selected. On motion by Mrs. Ella B. Bell and seconded by Mr. Jeff Newman, the Board voted in favor of an amendment of the Interim State Superintendent's salary as \$192,000 with the individual reverting back to the previous salary received prior to being selected.

SELECTION AND APPOINTMENT OF INTERIM STATE SUPERINTENDENT OF EDUCATION

Governor Robert Bentley presided over this portion of the meeting. Governor Bentley called for nomination. A motion was made by Mrs. Mary Scott Hunter for Dr. Philip C. Cleveland to serve as Interim State Superintendent of Education. The motion was seconded by Mr. Matthew Brown. Mrs. Betty Peters made a motion for Dr. Larry DiChiara, former Superintendent of the Russell County School System, to serve as the Interim State Superintendent of Education. This motion was seconded by Mrs. Stephanie Bell. No additional nominations were provided.

During the discussion period, the Board members reflected upon the individuals' work ethics. Dr. Cleveland was described as one who has a lot of experience in the Department who works well with local school systems, educational organizations, as well as the legislative branch of government. Further, he was described as a passionate leader. Dr. DiChiara was referenced as one who has served in excellent roles as well as a local superintendent and through his work in the Selma City School System.

Board members were in consensus as to how they felt about the candidates who applied and were especially pleased with the excellent representation in the Department. Dr. Jeffery Langham, Assistant State Superintendent of Education, was recognized as the second staff member, and one who also has district experience as a local superintendent, along with experience with the legislature. Governor Robert Bentley defined the role of the Interim State Superintendent as that of John the Baptist in preparing the way for the future superintendent, and on behalf of the Board he thanked those individuals who applied. The compiled list of applicants is filed in the State Board folder dated April 14, 2016.

Reference was made that the Interim State Superintendent of Education could not apply for the position of State Superintendent of Education. On a 7-2 vote, the Board members voted for Dr. Philip C. Cleveland as Interim State Superintendent of Education. Mrs. Betty Peters and Mrs. Stephanie Bell voted in favor of Dr. Larry DiChiara.

On motion by Mr. Jeff Newman and seconded by Mrs. Betty Peters, the Board members voted unanimously for Dr. Philip C. Cleveland to assume the role of Interim State Superintendent of Education effective Friday, April 15, 2016.

APPROVAL OF NOTICE OF INTEREST PACKET FOR THE STATE SUPERINTENDENT OF EDUCATION AND AUTHORIZATION TO POST NOTICE OF VACANCY

There were ten items to accept pertaining to the Notice of Interest Packet. On motion by Mrs. Mary Scott Hunter and seconded by Dr. Cynthia McCarty, the Board voted unanimously to accept the document. On motion by Mrs. Ella B. Bell and seconded by Mr. Jeff Newman, the Board voted 7-1 to amend Item 6 to reflect a superintendent or educational leader who has experience in managing an educational entity with substantial budgets. Mr. Matthew Brown voted no.

Dr. Cynthia McCarty made a motion that was seconded by Mrs. Mary Scott Hunter to add evidence of proven strong communication skills. The Board voted unanimously in support of the motion. This would be Item 11 on the document.

On motion by Mrs. Ella B. Bell and seconded by Mrs. Mary Scott Hunter, the Board voted unanimously to accept the document with the two amendments.

Governor Bentley had to leave, and Mr. Jeff Newman presided over the remainder of the meeting.

WHEREAS, Mrs. Sherrill Parris has served the education community, schools, teachers, administrators, students, and parents of Alabama as Senior Deputy State Superintendent of Education and has dedicated her career to the care, nurturing, well-being, and education of young people; and

WHEREAS, her ever expanding roles within the (SDE) soon encompassed the Division of Teaching and Learning as she assumed the position of Deputy State Superintendent of Education; and

WHEREAS, in this capacity, Mrs. Parris' responsibilities included the Office of Student Learning, as well as the Office of Learning Support, the Office of Teaching and Leading, and the Educator Effectiveness Section; and
