- **WHEREAS**, Alabama's career and technical education programs are preparing students for "a lifetime of success" by providing them opportunities to earn industry recognized credentials, workplace experience, and college credit while still in high school; and

- **WHEREAS**, every March the American School Food Service Association and the U.S. Department of Agriculture join together to celebrate National School Breakfast Week; and
- **WHEREAS,** the 2016 theme of National School Breakfast Week, "Take the School Breakfast Challenge," reminds parents, students, and school officials that a healthy school breakfast helps students power through the day; and
- **WHEREAS,** research has indicated that students who eat breakfast have better attention and memory; the quality of foods children eat impacts cognition; and poor nutrition is linked with absenteeism, hunger symptoms, and psychosocial problems; and
- **WHEREAS**, scientifically based food and nutrition information contributes powerful education benefits to all elementary and secondary students; and
- **WHEREAS**, the School Breakfast Program served over 44 million breakfast meals for the school year 2015-2016 to Alabama students:

**WHEREAS**, on February 7, 1926, under the leadership of Dr. Carter Godwin Woodson, director of the Association for the Study of Black Afro-American Life and History, Black History Week was established to spark awareness and broaden public interest in the deeds and accomplishments of Black Americans in this nation's history; and

WHEREAS, the celebration was expanded to Black History Month in 1976; and

**WHEREAS**, Black History Month is a time of remembering and celebrating African American history, culture and the experiences of our nation's African American community; and

**WHEREAS**, significant events of Black History have shaped our nation including the passage of the Emancipation Proclamation in 1863, the Civil Rights Movement, and the passage of the *Voting Rights Act of 1965* and the *Civil Rights Act of 1968*; and

**WHEREAS**, distinguished Black Alabamians and Black Americans with Alabama connections who have achieved state, national and global recognition for their contributions and sacrifices include Booker T. Washington, George Washington Carver, the Rev. Martin Luther King Jr., Rosa Parks, and General Colin Powell; and

**WHEREAS**, since 2011, the Alabama State Department of Education has teamed with AT&T to produce the African American History Calendar, a publication that highlights social justice advocates, medical pioneers, entrepreneurs, and entertainers whose contributions have made a lasting impact on Alabama and beyond; and

**WHEREAS**, the calendar that was created to identify role models for youth and honor notable African American achievers with ties to Alabama, is distributed to schools across the state as a resource tool for educators and students; and

**WHEREAS**, it is important that we continue to salute the positive contributions and achievements of African Americans throughout our nation and the state of Alabama:

**NOW, THEREFORE, BE IT RESOLVED,** That the Alabama State Board of Education does hereby endorse February 2017 as Black History Month in Alabama in appreciation of these and other Black Americans and Alabamians, and does hereby encourage the public schools to participate in this month-long celebration and to pay tribute to these and other men and women by teaching our children about them and their legacies to us today.

**WHEREAS**, *Alabama Administrative Code*, Rule No. 290-3-3-.56(4)(b)2., requires that approval by the Alabama State Board of Education shall be secured before a proposal for a new program is reviewed by the Office of Teaching and Leading of the Alabama State Department of Education; and

**WHEREA**S, the State Superintendent of Education has received from the Provost of Spring Hill College a written request to develop a Class B Chemistry (6-12) program; and

**WHEREAS**, the request lists the specific proposed program for which the Alabama State Board of Education approval is being sought, together with information concerning the factors to be taken into account in determining the need for the program; and

**WHEREAS**, Spring Hill College personnel have been advised that the proposed program may not be implemented prior to Alabama State Board of Education approval based on documentation of compliance with all applicable standards; and

**WHEREAS**, the State Superintendent of Education recommends that the program be reviewed by the Office of Teaching and Leading of the Alabama State Department of Education:

**WHEREAS**, the State Superintendent of Education has received from the president of the University of Mobile a written request to develop a Class B Special Education Teacher (K-6) program; and

**WHEREAS**, the request lists the specific proposed program for which the Alabama State Board of Education approval is being sought, together with information concerning the factors to be taken into account in determining the need for the program; and

**WHEREAS**, the University of Mobile personnel have been advised that the proposed program may not be implemented prior to Alabama State Board of Education approval, based on documentation of compliance with all applicable standards; and

**WHEREAS**, the State Superintendent of Education recommends that the program be reviewed by the Office of Teaching and Leading of the Alabama State Department of Education:

**NOW, THEREFORE, BE IT RESOLVED**, That the Alabama State Board of Education hereby authorizes a review of the following program:

Class B Collaborative Special Education Teacher (K-6)

Mr. Michael Sentance stated that information had been received from some Board members pertaining to the budget; however, with his employment beginning in October of 2016, he stated that future budget discussions will begin in August in order to have sufficient time to receive feedback from Board members and meet the November 1 deadline. Mr. Andy Craig will make adjustments based on information received.

## REPRESENTATION OF THE ALABAMA STATE BOARD OF EDUCATION ON THE 2017 STATE TEACHER OF THE YEAR COMMITTEE

On motion by Mrs. Stephanie Bell and seconded by Mrs. Ella B. Bell, the Board voted unanimously for Mrs. Jackie Zeigler to serve as the State Board Representative on the Alabama Teacher of the Year Committee.

On motion by Mrs. Ella B. Bell and seconded by Mrs. Stephanie Bell, the Board voted unanimously to adopt the resolution below and appoint Dr. Barbara Cooper as the Chief Administrative Officer for the Montgomery County School System.

### RESOLUTION AUTHORIZING MONTGOMERY COUNTY PUBLIC SCHOOLS INTERVENTION

**WHEREAS,** the Alabama State Board of Education and the State Superintendent of Education are vested by the Alabama Constitution and the laws of the state of Alabama with authority to exercise general control and supervision over the public schools of the State; and

**WHEREAS,** Alabama law further authorizes the State Superintendent of Education to review actions and orders of boards and superintendents of education related to matters seriously affecting the financial and/or education interests, to enforce the education laws and regulations of the Alabama State Board of Education, and to implement the educational policies of the Alabama State Board of Education; and

**WHEREAS**, local boards of education perform a state function at a local level and function as an arm of the state, subject to the general supervision of the Alabama State Board of Education; and

**WHEREAS,** more particularly, the *Code of Alabama*, including the *Educational Accountability* and *Intervention Act of 2013* (the "Act"), codified at Ala. Code §§ 16-6E-1 to -7, provides for intervention by the State Superintendent of Education of local boards under certain conditions; and

**WHEREAS,** on January 17, 2017, the State Superintendent of Education issued a show-cause letter to the Montgomery County Public Schools ("MPS") Board of Education, notifying MPS that intervention was being considered, explaining the deficiencies warranting the potential intervention, and instructing MPS to provide a written response to the letter; and

WHEREAS, at its January 20, 2017, meeting, the MPS Board of Education decided to consent to the intervention; and

**WHEREAS,** on February 7, 2017, the MPS Board of Education responded to the show-cause letter affirming the decision to accept intervention and work collaboratively with the Alabama State Department of Education; and

**WHEREAS,** in a spirit of collaboration, MPS provided extensive information and updates regarding the areas of concern; and

**WHEREAS**, the Alabama State Board of Education finds that the criteria set forth in the Act, including Ala. Code § 16-6E-4(5), that are necessary for educational intervention have been met:

**NOW, THEREFORE, BE IT RESOLVED,** That the Alabama State Board of Education does authorize education intervention of MPS under the Act and in such intervention the State Superintendent of Education shall be vested with all authority and power afforded to him under the Act; and

**BE IT FURTHER RESOLVED,** That, pursuant to the request of the State Superintendent of Education, Dr. Barbara Cooper is hereby appointed Chief Administrative Officer with full power and authority to exercise intervention authority under the Act subject to the supervision of the State Superintendent of Education; and

**BE IT FURTHER RESOLVED,** That intervention of MPS shall continue until MPS has become compliant with Chapter 13A, Title 16, *Code of Alabama* 1975 and, in the judgment of the State Superintendent of Education, has made suitable progress towards correcting the deficiencies leading to intervention including, but not limited to, in the areas of fiscal procedures, budgeting, accountability, and accuracy; CNP procedures; student transportation operations; student academic achievement; College and/or Career Ready rates; the gap between graduation rates and College and/or Career Ready rates; and the MPS graduation rate.

Done this 9th day of February 2017.

Mr. Michael Sentance stated that the meetings between the Alabama State Department of Education and the Montgomery County Board of Education have been productive. He commended Montgomery County Superintendent Margaret Allen and Montgomery County Board of Education members for their work in this matter. Mr. Sentance stated that the Montgomery County Board Members voted on January 20 to accept the Intervention and on February 7, 2017, sent a letter to the Alabama State Department of Education that acknowledged the Board members' vote. Mr. Sentance stated that the Department has a plan and are interviewing future individuals for employment. Board Members Ella B. Bell and Stephanie Bell expressed their support of the system and concurred that a great deal could be accomplished working together.

#### Superintendent's Report

Mr. Michael Sentance informed Board members that the Strategic Planning Committee for Math had a successful meeting and the Strategic Planning Committee for Science is excited about a scheduled meeting. Mr. Sentance stated that he attended the Governor's State of the State address and had been asked by Governor Robert Bentley to work with Secretary Jeana Ross in developing a coordinated plan from Pre-K through 16. He stated that Dr. Barbara Cooper, Mrs. Shanthia Washington, and Ms. Chasidy White will lead on developing a plan with Secretary Ross.
