PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:

How will the LEA determine the most important educational needs as a result of COVID-19?

The Albertville City Schools Leadership Team received input from each school level Leadership Team on the educational needs, by grade level, that resulted from the COVID-19 closure. Those needs were prioritized on at the system level and our plan was developed directly from the needs.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Our needs assessment indicated the most significant learning gaps from the disruption occurred in the lower elementary grades, where students attain and master literacy skills to become proficient readers. We recognize that being non-proficient in reading would also result in future deficiencies in all subjects; therefore, we are allocating funding for five (5) Orton-Gillingham-trained Intervention teachers to address this deficiency in K-3 reading. (\$450,000.00)

What is the LEA's proposed timeline for providing services and assistance to students and staff?

The funded activities/services will begin as soon as the plan is approved and will end when funds are expended. The anticipated time frame will be July 1, 2020-September 30, 2022.

How will the LEA use ESSER funds to promote remote learning?

Our plan includes funds for remote devices for students and staff, devices for remote WIFI access. Specifically, our plan includes the following: 1. 400 laptops for Pre-K-12th grade staff use in the event of another closure (\$500,000.00). Laptops for teacher use will allow teachers to continue online teaching from their home in the event of another long term closure. 2. 2000 chrome books for student use. This is the number needed for ACS to be one to one (\$316,210.00) in grades K-12. 3. 10 Cradlepoints to provide mobile WIFI access to all parts of the city (\$10,366.90). The Cradlepoints will be installed in various locations across the city and on buses for easy mobility. This will allow students who do not have WIFI at their home to access distant learning in a location close to their home. 4. MIFI data access (\$18,000.00). The MIFI's will be used mainly for students in grades 9-12 that do not have a means of traveling to one of our mobile Cradlepoint locations. Priority will be given to those students who need credits to stay on track with their cohort graduation.

4. Other Assurances and Certifications

The LEA Superintendent or his/her authorized representative assures or certifies the following:

- The LEA that receives ESSER funds will, to the greatest extent practicable, continue to compensate its employees and contractors during the period of any disruptions or closures related to COVID-19 in compliance with Section 18006 of Division B of the CARES Act. (2) that the control of funds provided to the local educational agency under each program, and title to property acquired with those funds, will be in a public agency and that a public agency will administer those funds and property;

(3) that the local educational agency will use fiscal control and fund accounting procedures that will ensure proper disbursement of, and accounting for, Federal funds paid to that agency under each program;

(4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.

(c) The Secretary may establish criteria and provide technical assistance for meeting the requirements of this section.

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.


