**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

A diverse team will develop the district needs assessment, conduct the needs assessment review and rate the data and develop an action plan that will benefit all those that were potentially impacted by school closure.

Student's learning gaps will be assessed using formative assessment data and evidence-based practices and addressed using proven strategies from tiered instruction and proven response to interventions (RTI) practices.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

Beginning March 18 2020, the district will use a reopening and recovery plan to help maximize student-learning opportunities. The district goals will be manageable and tied to the needs of both public and non-public school children in Bullock County.

**How will the LEA use ESSER funds to promote remote learning?**

As a priority, the district's technology plan will be revised to include additional technology to promote and support remote learning. The integration of additional technology for teaching and learning programs across the district will be on a wide scale to affect the quality of life for students and communities in Bullock County with limited resources.

**3. Equitable Services Assurances**

Beginning June 1, 2020, services to students and teachers in participating non-public schools will be provided consultation to determine needs of students impacted by COVID-19. The data and information obtained from the non-public schools will be used to develop short-term educational goals that will have a long-term impact on non-public school student achievement. Based on needs, an equitable services action plan will be developed and implemented to benefit all students impacted by school closure. Participating non-public schools will be allowed to expend funds until 9/30/22.

**4. Other Assurances and Certifications**

*The LEA Superintendent or his/her authorized representative assures or certifies the following:*

- The LEA that receives ESSER funds will, to the greatest extent practicable, continue to compensate its employees and contractors during the period of any disruptions or closures related to COVID-19 in compliance with Section 18006 of Division B of the CARES Act. In addition, LEAs that accept funds will continue to pay employees and contractors to the greatest extent practicable based on the unique financial circumstances of the LEA.   - (4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;
  - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
  - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

**6. Section 427 of the General Education Provisions Act Assurances**

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

A comprehensive needs assessment will consider the education and related service needs for all students, teachers, and other beneficiaries in the public school system as per special education, Section 504, English learner plans, homeless, and socioeconomic status as well as the identified special need of students, teachers and other program beneficiaries from participating public and non-public schools.




