Cleburne County Schools will administer a survey online to allow input from everyone. Administrators from the District met as a team to complete the Needs Assessment with input from all departments and schools.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Cleburne County Schools intends to use multiple criteria to assess and address learning gaps that have occurred over the disruption of our student's education. Our students in grades Kindergarten through third grade will use mCLASS with DIBELS while students in third through twelfth grade will use the Scantron Performance Series for benchmarks. Testing will be done at the beginning, middle and end of year to progress monitor growth.

What is the LEA's proposed timeline for providing services and assistance to students and staff?

Our plan is to begin addressing needs of some special education/504 students in July then have student's start back school the middle of August with staff coming back the week before for professional development and co-planning. Some of our staff will be preparing for those students who have selected to continue learning from home through the on-line platform while the remainder of our staff will be preparing for students to return to campuses. One day of staff learning will be on the "new normal" of how to keep everyone safe. The other professional development will include such topics as the Alabama Literacy Act, New Math Course of Study, Schoology and SchoolsPLP, DIBELS, and Review of Curriculum Guides for all grade levels. Based on student need as indicated through assessment measurements, there will be ongoing professional development throughout the school year; therefore, providing assistance to students until gaps are closed. These funds will be spent by September 30, 2022.

How will the LEA use ESSER funds to promote remote learning?

The first item we had to address was getting internet access to parts of our county that did not have it. We intend to partner with fire stations within the county, which already have internet access, to install a Cleburne County Schools wireless connection so that students can have more internet access within the communities in which they live. The second issue was having enough devices on hand so that we could check a device out to a student who did not have one - we will need to purchase 130 iPads and around 780 Chromebooks just in the first year. The following programs are loaded on devices for Cleburne County Schools students - ACCESS, Moby Max, STAR, StemScopes, Keyboarding without Tears, Go Math- Think Central, Reading Horizons, Global Scholar and Wonders Reading. Students in grades eight through twelve have PDF's of their textbooks loaded onto their device with access to the on-line learning components that accompany each textbook.

3. Equitable Services Assurances

4. Other Assurances and Certifications

 - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
 - (7) that in the case of any project involving construction -
 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
 - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
 - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?

Cleburne County Schools will make use of on-line resources for teachers and students. All students will be provided iPADS or chromebooks to continue learning should another crisis occur. We will set up remote learning access through community partnerships to establish parking lots for learning all over our rural county. Supplemental services will be provided via Zoom, Google Meets or packets depending on the parent preference. After school services will be offered at each elementary school to ensure that each student meets the criteria of the Literacy Act.


