<b>PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES</b>	

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAS will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

How will the LEA determine the most important educational needs as a result of COVID-19?
The Coosa County School System has completed a remote learning needs assessment, in order to aide in determining important educational needs, as they relate to remote access and instruction. Based upon those needs and considerations, the Leadership Team developed the attached budget.
How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?
Coosa County Schools is offering summer school instruction to those who qualify in grades 7-12. Additionally, summer online learning opportunities have been offered to those eligible students. Extended school year services through IDEA have been offered, as indicated through IEP Team recommendations.

At the beginning of the 2020-2021 school year, iReady diagnostic assessments will be administered in the areas of reading and mathematics for grades K-12. iReady diagnostic assessment results will be used to determine and address student learning gaps.

ESSER funds would facilitate remote learning by purchasing items for internet connectivity, assuring that our students have 1:1 access to technology, and securing licensing fees relating to educational programs.

#### 4. Other Assurances and Certifications

(4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the

Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

**6. Section 427 of the General Education Provisions Act Assurances**

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by •

- (1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

**What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?**

The Coosa County School System proposes to assist beneficiaries in overcoming barriers that may impede equal access to, or participation in, our program by securing community-wide hotspots, which would assist those students in accessing their online curriculum. In addition, the purchase of Chromebooks will allow students to download required materials each day that they are on campus, if they do not have the ability to download from their home. Students will have the opportunity to interact with their teacher while in their home through phone in options, such as Google Meet, as well.

Educators have received professional Development regarding accessing and providing remote learning, as well as related to specific educational programs. Future professional development opportunities are planned, as availability and need arise.

Mandatory grade level orientation will take place in order to provide hands-on training related to technology and programs provided to, and required of, students during this time of remote and on-site instruction.
