2. GRANT MATCHES AND REPORTING/ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

How will the LEA determine the most important educational needs as a result of COVID-19?

Culman City Schools (CCS) has utilized surveys of staff and parents to determine the educational needs as a result of COVID-19. We have also utilized the formative scores we had for 2019-20 Pre and Mid assessments to determine growth rates of students then compared that with standards missing from face-to-face instruction in determining missing areas of standard mastery.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

All CCS students will take approved formative Pre-Assessment upon the return to school in August 2020. These Pre-Assessments will include material that should have previously been mastered as well as upcoming standards. The Pre-Assessment scores will be analyzed using the SAGE tool from GlimpseK12, which will provide us accurate predicted 2019-20 Post scores from which we can assess the extended impact of "Summer Slide" due to COVID-19. Once school, grade level, and student specific summer slide are identified, CCS will utilize various instructional products and interventions to close the learning gaps within the first 3 - 4 weeks of the school year. For students who need continued supports they will receive those through interventions.

Private schools will submit their equitable service request to our district federal programs coordinator, be invited to all meetings related to service provisions, and have support in completing their plans from within CCS to ensure compliance. The timeline for services and assistance will be in accordance with our local plans, all federal and state regulations, and on-going for the duration of the private schools accepted plans.

4. Other Assurances and Certifications

The LEA Superintendent or his/her authorized representative assures or certifies the following:

- The LEA that receives ESSER funds will, to the greatest extent practicable, continue to compensate its employees and contractors during the period of any disruptions or closures related to COVID-19 in compliance with Section 18006 of Division B of the CARES Act. How will the LEA use ESSR funds to promote remote learning?

Cullman City Schools will utilize this funding to provide remote and online learning opportunities for students to be able to maintain learning in an ever-changing environment. Students will have access to Schoology content management platform as well as SchoolsPLP content and other technology software partnerships to support students in remediation, credit recovery options, and learning resources tied to current learning standards. Having these tools will help to keep students on track and will allow teachers to differentiate instruction to meet the needs of our diverse learners in an uncertain time.

In addition to the curricular supports we will have in place; teachers can also make use of video-conferencing tools to allow students social interaction when we are in restricted settings. This can support the social-emotional needs of students and assist with mental health concerns. For some of our families, remote learning is not an option due to the lack of devices at home. This funding will help level the digital divide in our households so that all students have access to the same content and can be provided with the same content and opportunities for remediation and learning.

The LEA Superintendent or his/her authorized representative assures or certifies the following:

 - (7) that in the case of any project involving construction -
 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
 - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
 - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
 - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

Section 427 of the General Education Provisions Act Assurances

- (a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

CCS will follow in all cases the established non-discriminatory board policy and all applicable federal and state laws.
