**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. **How will the LEA determine the most important educational needs as a result of COVID-19?**

Our Administrators will survey their teachers and various stakeholders to complete a school needs assessment. The administrative and technology team will meet at the central office to review the needs of each school and determine the greatest needs for the system.

**How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?**

We will administer grade level screeners using i-Ready for grades K-9. We will compile this data with our 2019-2020 mid-year data and determine students who are functioning below grade level. All students will be provided with appropriate technology and learning materials to address the identified needs. All teachers will review the standards covered by educational packets or Google Classroom assignments instead of face to face instruction to ensure students are ready to move on to new material.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

The timeline will be fluid to meet the needs of our students and faculty with distance learning and remedial services as determined by our needs assessments and schools' data. The first implementation is already underway in preparation for the safe opening of our schools for the new year. The funds will begin to be utilized as soon as the LEA application is approved by the SEA. All funds will be spent prior to Sept. 30, 2022.

**How will the LEA use ESSER funds to promote remote learning?**

All students' needs will be addressed through increased access to internet, virtual learning platforms, and age appropriate software aligned to standards. Technology devices and services will be purchased to support teachers and students for distance learning through all campuses. Faculty and staff will be trained in leading/assisting with instruction using digital platforms as needed.

  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers.
