**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

**How will the LEA determine the most important educational needs as a result of COVID-19?**

Our LEA determined the most educational needs as a result of COVID-19 by the perception of our students, teachers, and parents. We have reflected and discussed the things that worked and the things that need to be addressed and how we can provide the instruction to our students. We have surveyed parents to determine how many students would return to a traditional class setting. We have also established a remote learning task committee to review and plan our next steps.

**How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?**

Demopolis City Schools will use student data and administer IReady assessments to our students in an effort to identify student learning gaps. We will offer a summer reading intervention camp in July to our first and second grades, and we will offer three days in August for district-wide intervention opportunities and review for all of our students. We will monitor all data meetings so that any gaps are identified and immediate intervention is offered.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

This summer and during next school year PD will be provided for all of our teachers to ensure all virtual methods of instruction will be available. Also 4 remote learning days are embedded in our 2020-21 school calendar. On those days all students will receive virtual instruction. We will be purchasing additional chromebooks and making internet available via our school buses.

**How will the LEA use ESSER funds to promote remote learning?**

Demopolis City School System will use ESSER funds to promote remote learning by purchasing additional chromebooks, laptops and other technical resources. Teachers will be provided PD for remote teaching.

  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
  - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. (d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

**What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?**

Demopolis City School System is eliminating any barriers that could impede equal access to, or participation in, the program. In addition to virtual opportunities like zoom and google classroom, the use of teleconferences are used. Additional chrombooks, computers and hot spots will be purchased. Professional Development will be provided to all of our teachers to ensure all virtual/remote teaching can be used. We have embedded the 4 remote teaching days for our students during next school year. All of our students which include our EL, Special Education, Homeless, etc. will be given equal opportunities. We will provide accomodations as needed for these students.
