PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

How will the LEA determine the most important educational needs as a result of COVID-19?

Following a needs assessment performed by district administrators, we found the needs for some building repairs against the spread of COVID-19. As well as, technology needs for distance learning as well as traditional school. Also, the need for supplies for employees to conduct traditional school and be safe. Possible training for employees for distance learning as well as safety precautions for traditional school.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Students with Elba City Schools will be given an assessment at the beginning of the 2020-2021 school year to identify possible learning gaps for all students. Administrators will then work closely with teachers and staff to analyze data. Pacing guides will be adjusted to ensure that all standards, including the below grade level standards that are causing difficulty for students, are addressed throughout the 2020-2021 school year. Learning gaps will be targeted through small group instruction as well as explicit whole group instruction. Data tracking and analysis on progression of meeting learning targets and closing the achievement gaps will continue through nine week standards based assessments as well as daily formative assessments.

By providing more devices available to students to help promote distance learning as needed. These devices could be utilized in a traditional setting but mainly for all students especially those in need or without access outside of school.

 - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
 - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
 - (7) that in the case of any project involving construction -
 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
 - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
 - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
 - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

- (a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?

Providing enough technology to ensure all students could have access to devices if needed both on campus or for virtual learning. Also, providing some devices in the system if need for internet access at certain locations to provide equal opportunity for students without internet access. To provide training for teachers to be sure they have all the tools necessary to provide instruction safely in the traditional setting as well as virtually.
