**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

**2. Allowable Service(s) Assurance**

The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. **How will the LEA determine the most important educational needs as a result of COVID-19?**

Hale County School System (HCS) examined safety, achievement, and demographic needs. A survey was given to determine needs followed by meetings designed to prioritize system needs. The needs include: Various Assessments and Screeners, Technology, sanitation/health supplies and services, professional development (virtual learning and sanitation), and employee assistance program.

**How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?**

Performance Series Express, DIBELS, and ACT data from midyear will be used to determine the lowest performing standards in ELA & Math as well as individual student needs. Data will also be utilized to design summer learning for students. HCS will provide flexibility in areas such as virtual/physical scheduling options, Online registration, materials and supplies, after school tutoring, instructional support, and services that will help to meet the needs of our student population.

April/May/June- Planning for upcoming year  
July/August- Student support and staff professional development  
August 2020-May 2021- Continuous monitoring, support, and assessment of data/needs. Adjustments of priorities and needs will be made as necessary.  
Funds will be utilized and expended prior to September 30, 2022

**How will the LEA use ESSER funds to promote remote learning?**

HCS will ensure that all students will have access to appropriate devices that will allow for connectivity to Online/virtual learning. Teachers will receive professional development on virtual learning technology integration into content. The LEA is planning flexible scheduling to incorporate blended and virtual options.

Conversations with our local private school will focus on virtual materials, equipment, training for staff, and services for a clean and sanitized campus. HCS will make initial contact with the local private school with the intent to provide virtual consultation. Proposed timeline will include consultation/planning meeting in July 2020 and submission of individual school plans by August 14, 2020.

**4. Other Assurances and Certifications**

- The LEA Superintendent or his/her authorized representative assures or certifies the following:*

  - (4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;
  - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
  - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

**6. Section 427 of the General Education Provisions Act Assurances**

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.

(c) The Secretary may establish criteria and provide technical assistance for meeting the requirements of this section.

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

HCS will provide the resources, support, and opportunities needed to ensure that all students reach their full academic and social potential. HCS will promote effective practices for teachers, leaders, staff, and students such as instructional and cultural programs, mental health awareness, technology development, and appropriate community/business partnerships.




