**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

**How will the LEA determine the most important educational needs as a result of COVID-19?**

Through collaboration among school administrators, specialty area directors, and teachers about the areas that impact instruction, basic needs, and social emotional learning, the greatest needs will be determined and addressed. Professional development and cleaning supplies assist our staff in modeling safe, effective practices for students and their families. A dedicated COVID19 nurse will be hired to support health protocols. Contracted services to ensure high school seniors had a safe distance graduation ceremony. Contracted tutors/substitutes to support eLearning.

**How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?**

The district will facilitate discussions with regular and special education teachers regarding grade level teams and vertical teams to identify learning targets that could not be addressed and skills that were not mastered by students. This information will be used to determine best instructional alignment for 2020-2021. Star Reading and Math assessments will be used to determine the best instructional alignment for 2020-2021 with results determining Tier II & III intervention placements.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

Beginning March 14, 2020, the district began its planning for communication with staff/parents and establishing practices to support eLearning. All expenditures will be expended by September 30, 2022.

**How will the LEA use ESSER funds to promote remote learning?**

The funds will be used to provide Chromebooks, CIPA-compliant content filtering services, and hotspots for students and staff who report need of these resources.

In consulting with the private schools, they are opting to use funds for materials and supplies for cleaning, technology resources, and professional development. We are talking to each of our private schools individually. Most are using funds this summer and early fall as school starts back. All expenditures will be expended by September 30, 2022.

  - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
  - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

**6. Section 427 of the General Education Provisions Act Assurances**




