PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

How will the LEA determine the most important educational needs as a result of COVID-19?

Lawrence County will determine educational needs based on meetings and data from the following: District Leadership Team, Administrators, ARI Reading Coaches, Parent Surveys, student data from Learning Packets, Literacy Camp and other formative assessments. The needs of the district were cleaning supplies, health supplies and PPE, postage, technology, bus mileage, instructional supplies, instructional software, virtual PD, Instructional Specialist and Teacher for Virtual/ Blended school, additional days for nurses to prepare and an additional nurse.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Lawrence County will assess student learning gaps by reviewing learning packets, benchmark assessments during literacy camps, benchmark assessments from online platforms, and other formative data. Learning gaps will be addressed by providing students with intensive whole group/ small group instruction on skills/ standards lacking at each grade level.

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.


