PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:
 The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. How will the LEA determine the most important educational needs as a result of COVID-19?

The superintendent held staff meetings to analyze the school system's greatest need during the COVID-19 crisis. After receiving feedback from central office staff members, local school administrators and teachers, parents, and community stakeholders, the leadership team determined that iPads and chromebooks needed to be purchased for K-12 students. These devices would enable students to communicate with their teachers during a school closure and complete necessary assignments.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Vertical and horizontal grade level and departmental meetings will be conducted at the beginning of the school year to determine students' strengths and weaknesses in the core subjects. During these meetings, data from grade level/departmental formative assessments will be analyzed to target deficiencies in student learning. Strategies and action steps will be developed to address students' academic needs.

What is the LEA's proposed timeline for providing services and assistance to students and staff?

During the summer months, central office staff members and local school administrators will work collaboratively to develop an action plan for students returning to school after the COVID-19 crisis including strategies for a future crisis. As soon as the newly-purchased devices arrive, the technology department will work diligently to prepare them for student use. Teachers will receive additional professional development for iPads, chromebooks, and distance learning. during pre-inservice. At the beginning of the school year, parent trainings will be conducted at the local schools to model the use of the newly-purchased devices and answer questions they may have concerning distance learning. All ESSER funds will be used by September 20, 2022.

How will the LEA use ESSER funds to promote remote learning?

One hundred percent of ESSER funds provided to the LEA will be used to purchase devices for students. K-1 students will receive iPads, and students in grades 2-12 will receive chromebooks. Training will be provided to K-12 teachers at the beginning of the school year to ensure they are equipped with the skills needed to operate the devices and provide distance learning to students.

3. Equitable Services Assurances

The LEA Superintendent or his/her authorized representative assures or certifies the following:

- The LEA receiving ESSER funds will provide equitable services to students and teachers in non-public schools as required under Section 18005 of Division B of the CARES Act.

One of the two private schools in Saraland City elected to apply for ESSER funds. The school decided to allocate 100% of these funds to chromebooks. The LEA Federal Programs Director met with the headmaster in June 2020 to collaboratively complete the equitable service plan. As soon as the LEA receives the devices, they will be given to the private school. The LEA hopes to receive all shipments no later than October 2020.

OTHER ASSURANCES AND CERTIFICATIONS

4. Other Assurances and Certifications

The LEA Superintendent or his/her authorized representative assures or certifies the following:

- The LEA that receives ESSER funds will, to the greatest extent practicable, continue to compensate its employees and contractors during the period of any disruptions or closures related to COVID-19 in compliance with Section 18006 of Division B of the CARES Act. In addition, LEAs that accept funds will continue to pay employees and contractors to the greatest extent practicable based on the unique financial circumstances of the LEA. The application shall cover the participation by that local educational agency in all such programs.

(b) The general application submitted by a local education agency under subsection (a) shall set forth assurances

(1) that the local educational agency will administer each program by the application in accordance with all applicable statutes, regulations, program plans, and applications;

(2) that the control of funds provided to the local educational agency under each program, and title to property acquired with those funds, will be in a public agency and that a public agency will administer those funds and property;

(3) that the local educational agency will use fiscal control and fund accounting procedures that will ensure proper disbursement of, and accounting for, Federal funds paid to that agency under each program;

(4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

- (a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -
 - (1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and
 - (2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.
- (b) The Secretary shall require each applicant for assistance under an applicable program (other than an individual) to develop and describe in such applicant's application the steps such applicant proposes to take to ensure equitable access to, and equitable participation in, the project or activity to be conducted with such assistance, by addressing the special needs of students, teachers, and other program beneficiaries in order to overcome barriers to equitable participation, including barriers based on gender, race, color, national origin, disability, and age.
- (c) The Secretary may establish criteria and provide technical assistance for meeting the requirements of this section.
- (d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?

No student is denied access to academic programs on the basis of gender, race, color, national origin, disability, age, or economic status. The system's programs are open to all students. Teachers and other program beneficiaries are included in all meetings and professional development opportunities applicable to their jobs and professional needs. Central Office staff members and local school administrators evaluate all programs annually to determine their effectiveness, including teacher and student success with the programs.




