PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

How will the LEA determine the most important educational needs as a result of COVID-19?

Surveys of parents, principals, and teachers after the prolonged school closure in March helped TCSS assess the most important educational needs of our district. It was found that a lack of devices and internet service greatly impacted our ability to provide virtual learning across our district. We also were lacking in a Learning Management System and a virtual program to reach K-8 students. Because of this, funds were expended to provide paper copies of materials to students. We also determined that upon students' return to school, we would need to purchase additional cleaning supplies, PPE, thermometers, and provide professional development related to cleaning in order to prevent the spread of COVID-19.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Students will be assessed using iReady upon their return to school. As learning gaps emerge, intervention and remediation will be provided in multiple ways during and after school. Students will be retested throughout the school year to determine what instructional practices may be needed in order to help them make progress.

What is the LEA's proposed timeline for providing services and assistance to students and staff?

Services will be provided to students in order to close achievement gaps caused by the prolonged closure through literacy camps during the summer of 2020. Funds will be used to pay teachers and to purchase supplies needed for the camps. Funds will be used immediately to reimburse schools for the costs of copies, postage, etc. from our extended school closure beginning March 13, 2020. Funds will also be used immediately to provide professional development to teachers and administrators in the areas of assessment, learning management system, virtual learning, and proper cleaning procedures. We will also spend funds immediately to purchase cleaning supplies and equipment to use in all schools in hopes of preventing further closures. All funds will be expended by 9/30/2022. ~~Will be expended by 9-30-2022.~~

How will the LEA use ESSER funds to promote remote learning?

ESSER funds will be used to provide professional development for teachers so that they can immediately begin providing remote learning opportunities for students who do not return to campus in the fall. They will also be integrating remote learning into their physical classrooms so that students are familiar with the process in case we have further closures.

3. Equitable Services Assurances

There is one private school in our district. Funds will be available to them to provide services to their students in the areas allowed under the CARES Act. They will be able to access the funds set aside for them by working with the Director of Federal Programs who will follow all Federal guidelines for providing these services. Services include technology, cleaning supplies, training, etc. All services will be provided and end by 9/30/2022.

4. Other Assurances and Certifications

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

Funds will be spent on devices, direct services, and supplies that will all prevent or overcome barriers.
