PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:

The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. The United States Department of Education **does not** consider the following to be an allowable use of ESSER funds, under any part of 18003: 1) subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs or 2) expenditures related to state or local teacher or faculty unions or associations.

How will the LEA determine the most important educational needs as a result of COVID-19?

The District has established a Covid-19 leadership response team that includes administrators, teachers, parents, and local health officials. These team members assessed the District's needs in relation to academics, health and safety, facilities, transportation, Child Nutrition, and school governance. The needs in order of priority are (1) extra personnel; (2) Internet access for students without it; (3) Devices; (4) Remote learning software; (5) Teacher training; (6) Instructional supplies; and (7) Sanitization and Health supplies.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

The District plans to aggressively approach the learning gaps by reteaching critical skills that were covered after the schools closed in March. The district is also planning to employ retired teachers to provide small group and individual instruction during the day to students needs extra assistance. Additional tutorial services shall be provided to at-risk students in after school programming. The District will use STAR Reading and Star Math to conduct formative assessments in those areas for all students in grades 3-12. They will use STAR Early Literacy for grades k-1. Students will also participate in all state assessments.

What is the LEA's proposed timeline for providing services and assistance to students and staff?

Services begin upon approval of the application. The services will continue through Sept. 2022.

How will the LEA use ESSER funds to promote remote learning?

The District plans to employ 8 remote learning teachers to deliver instruction to students in grades K-8 that choose 100% e-learning. The District will use the Schools PLP curriculum provided by the ALSDE, and the Schoology platform. The District is planning to contract with Schools PLP to purchase an additional prescription for grades 9-12 for times when blended learning may become necessary for both students in 9-12 and for the Career Tech program.

3. Equitable Services Assurances

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.
