WHEREAS, Alabama's citizens can demonstrate their commitment to drug-free, healthy lifestyles by wearing and displaying red ribbons and encouraging a drug-free lifestyle during this week-long campaign; and

WHEREAS, dyslexia impacts between 10 percent and 20 percent of the children in Alabama schools; and

WHEREAS, through effective dyslexia screening, students with dyslexia can be identified as early as kindergarten, long before their learning challenges have resulted in learning disabilities; and

WHEREAS, early identification and intervention will equip many students with dyslexia for success in school and in life; and

WHEREAS, the Alabama State Board of Education has specifically addressed dyslexia within the *Alabama Administrative Code*; and

WHEREAS, the Alabama State Board of Education has committed itself to supporting Alabama schools and teachers with resources, materials, and professional development; and

WHEREAS, the Alabama State Board of Education is fully committed to the goal that every child will read on grade level:

NOW, THEREFORE, BE IT RESOLVED, That the Alabama State Board of Education recognizes October as Dyslexia Awareness Month and encourages school systems to engage their schools, families, and communities in activities that create a culture of understanding, support, encouragement, and learning for dyslexic students.

WHEREAS, over the past decade, there has been a growing movement among educators, national employers, and top business professionals to further focus American's high school curriculum on college preparation and career development; to remain competitive in today's growing global economy, Alabama's students must continue to be provided the highest quality educational experience possible; and

WHEREAS, for the ninth consecutive year, our state has celebrated Alabama College Application Campaign and third year Cash for College campaign annual events developed by the Alabama State Department of Education and Alabama Possible to celebrate the importance of students continuing their educational goals after graduating high school and Campaigns; and

WHEREAS, each year, millions of students nationwide apply for financial aid services and complete the FAFSA; and

WHEREAS, an estimated sixty percent of high school seniors qualify for a Pell Grant in Alabama. Fifty two percent completed the FAFSA as of June 19, 2020, leveraging an estimated \$66,503,903 in Pell Grant aid across the state of Alabama; and

WHEREAS, nationwide more than 7,300 host sites were held this year to celebrate College Application Campaign, 763,400 students participated nationwide, and 1.2 million applications were submitted; and

WHEREAS, Alabama had 346 host sites, over 130 high schools were recognized for 100% of their seniors completing a college application. Fifty-six colleges and universities participated in the Alabama College Application Campaign Fee Waiver Program and over 74,661 applications were submitted; and

EXECUTIVE (INCLUDES LEGAL AND PUBLIC INFORMATION)

Dr. Eric G. Mackey stated that there was no report necessary for the month of October.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey thanked Mrs. Sally Smith, Executive Director of Alabama Association of School Boards, for the use of their building to host the Alabama State Board of Education Meeting/Work Session. Dr. Mackey stated that technology renovations of the Gordon Persons Building (GPB) Auditorium and Room P103 were incomplete at this time and hopes to be back in the GPB in November. Dr. Mackey thanked the principals who were honored today for their hard work and being very engaged.

Dr. Mackey informed the Board that one topic to be discussed today during the Work Session and next month, is the English Language Arts Courses of Study that ties into the Literacy work that is being completed. Dr. Mackey stated that members of the Board, Dyslexia Advisory Council (DAC), Literacy Task Force, and Alabama Committee on Grade-Level Reading (ALCOMGLR) were invited to review the standards. Dr. Mackey stated that having all three groups review the standards has never been done in the past. Dr. Mackey stated that the collaboration shows how committed the Board, everyone who works for the Board, and all the volunteers are to getting things right. Dr. Mackey stated that the DAC has reminded the department about encouraging more people to become Certified Academic Language Therapists (CALT). Dr. Mackey stated that the Board has requested more funding to get more people CALT trained. He also stated that the department is asking to provide a stipend for those who attend the CALT training.

Dr. Mackey stated that Language Essentials for Teachers of Reading and Spelling (LETRS) training is another interest. Dr. Mackey informed the Board that in 2018, there were few to none LETRS-trained teachers in Alabama. Dr. Mackey stated that in just two and a half years, Alabama has 224 elementary teachers who graduated in the two-year program and 657 graduated in the one-year program that is targeted toward early childhood (pre-k and kindergarten) teachers in general. Dr. Mackey stated that Alabama has gone from close to none to over 800 teachers trained in LETRS. Dr. Mackey stated that there are 8,522 teachers enrolled in the elementary school program and 696 more teachers enrolled in the early childhood program. Dr. Mackey stated that combined, Alabama is approaching the 10,000 number of teachers in the LETRS training program. Dr. Mackey emphasized that the teachers are voluntarily going through a rigorous training without a stipend because they want to be better teachers of reading. Dr. Mackey stated that there are other programs, but this is high-quality professional development for Alabama teachers. Dr. Mackey stated that Alabama has 700 teachers on the waiting list.

Dr. Mackey stated that the Board did a recognition today of Cash for College awards. Dr. Mackey recognized on the following schools, teachers, and administrators who were honored.

Dr. Mackey stated that the department was asked in what ways help is being provided to schools during these challenging times. He stated that one of the many ways the department has been working with school superintendents and principals is to provide waivers for qualifying high school seniors during this difficult time. Dr. Mackey stated that seniors who have met their graduation requirements and college- and career-ready credentials can get waivers. Dr. Mackey stated that some seniors are going to school half days and some are finishing early. Dr. Mackey stated that the department received 883 requests for waivers from particular schools for particular students. Dr. Mackey stated that 479 waivers were approved, 323 are in the approval process, and only seven were denied. Dr. Mackey stated that granting waivers for qualified high school seniors is one of the ways the department has gone above and beyond what the Board has asked. Dr. Mackey stated that granting waivers is one example of the work that the Alabama Board of Education is promoting.

There being no other business before the Board, on motion by Dr. Cynthia McCarty and seconded by Mrs. Tracie West, Board members voted unanimously to adjourn the meeting at 11:15 a.m. The next Alabama State Board of Education Meeting for Elementary and Secondary Education will be held on Thursday, November 12, 2020, at 10 a.m. in the Auditorium of the Gordon Persons Building followed by the Work Session.
